1. FRIENDS BOARD OF DIRECTORS

Discussion regarding the reorganization of the Friends of FEC Board of Directors. The idea is to have two of the FEC Board Members and three members of the public on the Friends Board of Directors.

2.FRIENDS OF FEC FY-2020/21 BUDGET

Secretary Seaman commented that CAPRI would not deny the claim if the Civil Engineer stated it needed to be done, otherwise they would be on the hook if something happened to the bridge. Secretary Seaman asked the General Manager if he knew what the additional cost to replace it with the same kind of bridge that they have a Cottage. Secretary Seaman also wanted to know what the plan was about bollards to keep vehicles off the bridges. The decision was made to table the meeting until next week when all the information would be available for the Board to make an informed decision.
