On a motion by Seaman, seconded by Higgins the board approved the consent agenda. The vote was Ayes – 4, Noes – 0, Absent – 1, Abstained - 0

### 6.1 CSDA Board of Directors Election – Term 2023-2025; Seat B – Sierra Network

Director Seaman endorsed Candidate Elliot Mulberg. Chair Stricklin, Vice Chair Higgins and Secretary Dias also endorsed Candidate Mulberg. Director Seaman made a motion to vote for Candidate Mulberg with Chair Stricklin seconding the motion. Motion passed on a vote of 4-0-1-0.

#### 6.2 Preliminary Budget Fiscal Year 2022/23

Secretary Dias presented a motion to adopt the following:

- a. Resolution 2021/22-26, Approving the General Fund Preliminary Budget for 2022-23
- b. Resolution 2021/22-27, Approving the Parks Maintenance and Recreation Improvement District (Assessment # 1) Preliminary Budget for 2022-23
- c. Resolution 2021/22-28, Approving the Parks Maintenance and Recreation Improvement District (Assessment # 2) Preliminary Budget for 2022-23

Vice Chair Higgins seconded the motion. Resolutions adopted by a vote of 4-0-1-0.

## 6.3 Declaring the Intention to Continue Assessments for Fiscal Year 2022-2023

Vice Chair Higgins made a motion to adopt the assessment #1 and #2 resolutions:

- a. Resolution 2021/22-30, Declaring the Intention to Continue Assessments for Fiscal Year 2022-23, Preliminarily Approving the Engineer's Report, and Providing for Notice of Hearings on July 21, 2022, for the Parks Maintenance and Recreation Improvement Assessment Districts. (Assessment #1)
- b. Resolution 2021/22-31, Declaring the Intention to Continue Assessments for Fiscal Year 2022-23, Preliminarily Approving the Engineer's Reports, and Providing for Notice of Hearings on July 21, 2022, for the Parks Maintenance and Recreation Improvement Assessment Districts (Assessment #2).

Director Seaman seconded the motion to adopt. Resolution adopted by a vote of 4-0-1-0.

#### 6.4 Approve the Representation Letter for the 2020-2021 Fiscal Year Audit

Secretary Dias made a motion to approve the Representation Letter from Larry Bain, CPA to complete the audit for the 2020-2021 fiscal year, with Vice Chair Higgins seconding the motion. Motion passed on a 4-0-1-0 vote.

# <u>6.5 Approve the Meliora Public Safety Consulting Contract for an Evaluation of the Police</u> Department

Secretary Dias made a motion to approve the contract with Meliora Safety Consulting to evaluate and make recommendations for the police department's operations, Vice Chair Higgins seconded the motion.

Director Seaman stated that he is skeptical regarding the direction he sees things headed but he would not go against the recommendation or the Security Committee. He would rather spend the money into transitioning into a joint-powers authority.

Motion passed on a 4-0-1-0 vote.

# 7.1 Discussion Update with San Juan Unified School District (SJUSD) Regarding the Katherine Johnson Middle Proposed School Site and FEC's Creekside Nature Area

The General Manager gave an update on the ongoing discussions with the San Juan Unified School District. She met with Frank Camarda with SJUSD, FEC's Superintendent of Parks Dan Williams and FEC residents Don and Jennifer Harris. There would be access to the Nature Area from both Lacy Lane and Belport. There is ongoing discussion regarding access to the nature area from Kent. SJUSD is not going to build on the flood plain. Director Seaman would like the public to tell us what they want at a public meeting. He noted that, since the school district

cannot build on the flood plain, there are grant funds potentially available for other entities to pursue projects for open space use there. In general, he is glad of the progress being made, but is concerned that there is more to be done and the clock is ticking."

## 7.2 General Manager's Report

General Manager attended the CARPD Conference. Reported Supervisor Desmond held a meeting at FEC regarding the Creekside construction. No new items to report for Babcock Park. She met with East Bay Regional Park Chief to get his thoughts on running a police department.
